SECRETARY'S REPORT:

Timothy Mattice opened a discussion regarding the Housing Authority's Bank Account Balances and the financial state of the authority. Accounts are looking good.

Accounts receivables were discussed. One vacancy at the current time. The arrears are increasing monthly due to the residents that have applied to the Emergency Rental Assistance Program (ERAP), evictions still cannot take place and those residents are still not paying rent. We are awaiting to see if funding will be available for the arrears. Currently there is no money available at this time for ERAP and there's no guarantee that there will be funding. We are working with agencies and with several residents to find funding to help with arrears.

New York State Public Housing Authorities Directors' Association (NYSPHADA) is actively working with HUD and Congress to get funding to address this massive problem. The federal government rent moratorium has created this problem that they will need to address. There are many housing authorities across the country all in the same situation. If this problem doesn't get addressed soon – many housing authorities may face closing their doors. There are going to be some very difficult decisions and procedures that are going to have to take place and the State will have to mandate the action to proceed. ERAP must have a sunset date and the housing authorities have to be given the authority to move forward with evictions.

The profit and loss statement is still in the positive net income. Everything is stable at this time. Floor was opened for questions. None were asked.

Acceptance of the 2022 Capital Fund Program Grant

WHEREAS, the Catskill Housing Authority's Board of Commissioners approved Resolution No.FY22-R-13 on June 8, 2022 accepting the 2022 Annual Capital Fund Program Grant allocation; and,

WHEREAS, Every year the Catskill Housing Authority (CHA) receives a Capital Fund Program (CFP) grant from the U.S. Dept. of Housing and Urban Development (HUD). CFP grants are used by CHA to fund physical and management improvements, and general operating expenses; and,

WHEREAS, The U.S. Department of HUD has estimated the 2021 CFP funds for Catskill Housing Authority to be \$274,598 (See attached HUD form 50075.1); and,

WHEREAS, To obtain access to the grant funds CHA must provide HUD various documents (referred to as grant submission documents). In addition, A public hearing and 45 day statutory public review and comment period of the CFP grant submission documents is also required. The review and comment period for the 2022 CFP grant submission documents began April 1, 2022 and ended on May 16, 2022; and,

WHEREAS, a public hearing has been published and scheduled for June 8, 2022 at 5:00pm at which time anyone from the public may submit comments regarding the 2022 CFP Program. All comments will be incorporated into the application and meeting minutes; and,

NOW, THEREFORE, BE IT RESOVLED, that the Board of Commissioners hereby accepts the 2022 Capital Funds Program Grant of \$274,598 Capital Funds to Operations BLI 1406.
